# **MINUTES of PREVIOUS EXECUTIVE MEETING:**

Moved Mario and seconded Steve that the minutes of the previous meeting, 19 August 2024, be accepted as a true and correct record.

#### **MATTERS ARISING:**

There was discussion on the Last Man Standing concept replacing the F15 format. To revamp the F15 competition the Executive plan to change the format to Last Man Standing. In short this involves a 20 over innings, with 8 a side and 5 ball overs. All 8 wickets are needed to bowl a team out. When the seventh wicket falls, the Last Man Stands on their own. The Last Man can only score 2, 4 or 6 off any ball. It was decided to advise the clubs of the new concept with clubs able to nominate a team 10am Friday, 27 September.

# **PRESIDENT'S REPORT:**

Peter spoke on the CricketWest Forum. Several SMCA clubs did not attend. He felt overall the function went well although it went too long. There was a query on how people got elected to the CricketWest Board.

CricketWest had denied Ferndale-Lynwood's request to join the SMCA. They have applied for next season. Peter was concerned that a request for written information on a policy that allowed CricketWest the opportunity to deny the request took two weeks to be received. He wondered where the policy is located for interested parties to read. It does not appear to be on a web site. This policy did not seem to affect Canning Vale's transfer to the SMCA.

#### ADMINISTRATOR'S REPORT:

Gary has updated the SMCA web site with email addresses for all Executive members as well as with details of the role/s each member undertakes.

Norm and I had a meeting with John Sherry at the WACA. John is the High-Performance Umpire Coordinator for WA Cricket and was able to assist us with setting up OfficialsHQ

We have set up a Players Report on Umpires which will be emailed to the team captain 6 hours after the start of play on the last day of the match.

Consideration being given to an Umpires Report on the match also.

The Jim McKenna and Ian Hale Medals have been set up on Officials HQ.
